### **Preface**

This report presents International Merchandise Trade Statistics of The Gambia (IMTS) for fourth quarter 2023. It aims to show the outlook of trade between The Gambia and its trading partners during the period under review. It could also serve as a catalyst to enhance the investment drive of the country. The international merchandise trade statistics unit under the Directorate of Economic Statistics of the Gambia Bureau of Statistics (GBoS), receives monthly raw trade data extracted from the Customs and Exercise Department of the Gambia Revenue Authority (GRA) Database (ASYCUDAWORLD) in American Standard Code for Information Interchange (ASCII) format for processing using EUROTRACE<sup>1</sup>.

Data cleaning is continuous as various tables are produced to feed into the reports. The database is therefore updated from time to time to take account of adjustments made from the input source.

The report contains a wide range of trade statistics between The Gambia and its partners. This avails data users with information to facilitate planning and decision making. Data can be provided to users based on the level of breakdown requested up to six (6) or eight (8) digits according to the Harmonized commodity description and coding system (HS).

The quarterly report contains data on the Trade Balance, Imports and Exports by major trading. The latest quarterly reports can be accessed on the Gambia Bureau of Statistics' website (<a href="www.gbosdata.org">www.gbosdata.org</a>). For users who have specific data needs, the international merchandise trade statistics Unit could offer the necessary assistance.

The Gambia Bureau of Statistics wishes to express its profound gratitude to the ASYCUDAWORLD (Automated System Customs Data) Unit of The Gambia Revenue Authority (GRA), for making available the necessary data for the compilation of the International Merchandise Trade Statistics. We hope that users will find this report useful.

### Concepts and definitions

**Monthly trade summary:** Includes imports, exports and re-exports and total exports disaggregated by month.

**Trade flow by selected continents and economic zones:** Is the value of trade between The Gambia and selected geographic and economic zones.

**Direction of trade:** Trade flows from and to main trading partners. The ranking is done based on highest ten by value in (GMD) and country.

**Trade flow by top ten products:** This indicates trade flows (import, exports, re-exports) by main products sorted based on the highest Cost Insurance and Freight (CIF) or Free on Board (FOB) value in (GMD'000) at 2-digit Harmonized System product code which groups related commodities.

**Export trade:** The exports of merchandise goods are valued at F.O.B and it refers to all movable goods. Share of domestic exports to total trade is the value of all goods exported to the rest of the world divided by total trade multiply by 100.

**Import trade:** The value of imported goods includes the cost, insurance, and freight (C.I.F). Share of imports to total trade is the value of all goods imported from the rest of the world divided by total trade multiply by 100.

**Total Exports:** This is the value of domestic exports plus re-exports.

# **Executive Summary**

- The total value of imports in the third quarter of 2023 compared to the fourth quarter of 2023 declined from GMD13.1 billion to GMD13.0 billion.
- Fourth quarter 2022 shows larger importation of mineral fuels and Cereals compared to the same period in 2023.
- Animal or vegetable fats and oil, oil seeds and Oleaginous fruits; fish and crustaceans, were mostly exported in the fourth quarter of 2023.
- Belgium, Senegal, and India were the main import partners during the fourth quarter of 2023.


# Summary of Quarterly Trade Statistics 2022-2023

Table 1 below shows the quarterly trade statistics for fourth quarter 2022 and 2023. The total value of imports in the third quarter of 2023 declined slightly from GMD13.1 billion to GMD13.0 billion in the fourth quarter of the same year. Whereas the value of imports between the fourth quarter of 2022 and 2023 declined from GMD13.9 billion to GMD13.0 billion.

The value of total exports (i.e., domestic exports +re-exports) in the third quarter of 2023 decreased from GMD 653.5 million to GMD541.1 million in the fourth quarter of 2023. Whereas the value of total exports in the fourth quarter of 2022 increased from GMD340.9 million to GMD541.2 in the same period for 2023.

The trade balance in the third quarter of 2023 increased slightly from GMD12.4 billion to GMD12.5 billion in the fourth quarter 2023. However, the trade balance between the fourth quarter of 2022 and 2023 decreased from GMD13.6 billion to GMD12.5 billion.

### Imports and Exports by Products

### Import by Products

Figure 2 shows the top three products imported in the fourth quarter 2022 and 2023 respectively. Although all the products imported are the same for both quarters. Of the overall imports the most imported product was mineral fuels. During the fourth quarter of 2023, 46.6 percent of this product was imported compared to 40.8 percent of the product in the same period in 2022. This was followed by importation of Electrical machinery 9.4 percent in fourth quarter of 2022, whereas cereal (6.1 %) was the second highest product imported in the fourth quarter 2023. The third most imported product was vehicles which shows that less of the product was imported during the fourth quarter of 2023 (4.8 %) compared to 2022 (6.5 %).







### Exports by product




Figure 3: Imports of Selected Products for Fourth Quarter 2023 Values (GMD'000)

Exports of top three products from figure 3 shows that, Animal or vegetable fats and oil, Oil seeds and oleaginous fruits, Fish and crustaceans were mostly exported in the fourth quarter of 2023 and 2022. Furthermore, oil seeds and Oleaginous fruits (47.5 %) was the highest product exported in 2023, while Animal or vegetable fats and oil (31.6 %) was the most exported product in 2022 and fish and crustaceans were the least exported product in both 2022 (15.1 %) and 2023 (11.5 %) respectively.

# Imports of selected products for fourth quarter 2023

Imports of selected products for fourth quarter 2023 shows that the highest imported product was rice GMD (481.0 million), followed by total cement GMD (274.1 million), refined cane sugar GMD (224.8 million) and milk and milk products GMD (166.8 million).

# Trade by partners

### The Gambia main import trade partners

Table 3 below shows imports from partners for the fourth quarter of 2022 and 2023. The top three countries where most of the goods into the country were imported from during the fourth quarter of 2022 were United Arab Emirates (18.4 %), China (15.0 %) and Cote d'Ivoire (10.6 %). Whereas, during the fourth quarter of 2023, most of the imports were from Belgium (25.2 %), Senegal (10.7 %), and India (8.3 %).

### The Gambia main export trade partners


Table 4 below shows that China had the largest share of exports from The Gambia, however, its share increased from 52.3 percent in the fourth quarter of 2022 to 61.1 percent in the same quarter of 2023. The second largest partner of exports from The Gambia was to Vietnam in the fourth quarter of 2022 (7.8 %) and to India (12.4 %) in 2023. The third partner exports from the Gambia for 2022 and 2023 was Turkey (7.4 %) and Republic of Korea (4.8 %) respectively.



# Intra Regional Trade (ECOWAS)

Figure 5 shows the imports from main ECOWAS partners in the fourth quarter of 2023. Senegal GMD (1.3 billion) had the highest import value, followed by Cote d'Ivoire GMD (877.4 million) and Nigeria GMD (237.7 million).
